

NOMINATION FORM

Please review the questions and criteria below, then fill out your prepared response on the online form at www.acgc.ca/nominate. Nominations are open from November 2 to November 27, 2023.

Eligibility Criteria

To be eligible, nominees must meet all the following criteria:

- Is 10 to 30 years of age as of March 31, 2024;
- Plays an active role in making a positive difference and models civic engagement globally and/or locally;
- Meet at least ONE of the following
 - o (1) Currently resides in Alberta
 - o (2) is affiliated with an ACGC member abroad
 - o (3) is studying or working outside Alberta but considers Alberta their permanent home
 - OR (4) normally resides outside Alberta but is currently enrolled in a post-secondary program inside Alberta;
- Is willing to participate in the creation of the publication, where their information and image(s) will be displayed to the general public; and
- Is easily contacted (in Canada or otherwise reachable).

Nominee Information

We require the following information of nominees:

- First and last name
- Place of residence
- Phone number
- Email address
- Age (as of March 31, 2024)
- Gender
- Other identity factors
- Is the nominee aware of this nomination?
 - If not, please explain why. Please note that in this nomination, we are also requesting
 the contact information of a referee who is not the nominator, not a family member of
 the nominee and should be able to speak to the nominee's character and/or
 accomplishments.

Nominator Information

We require the following information of nominators:

- First and last name
- Phone numbers



- Email address
- Relationship to nominee (non-family members are preferred; however, for folks who face barriers or lack a community ally to support them through the process, we allow self-nomination and family nominations.)

Eligibility

The online form will ask you to verify the nominee's eligibility:

- Is the nominee between 10-30 years of age as of March 31, 2024?
- Is the nominee (a) currently residing in Alberta, (b) affiliated or working with an ACGC member abroad, (c) studying outside Alberta but considers Alberta home?
- Please provide the name, email and phone number of a referee that is not a family member of the nominee and can speak to the nominee's character and/or accomplishments. This referee may be contacted during the selection process.

Character of Nominee

Through the following questions, the online form will ask you to explain what makes this nominee special.

- Why are you compelled to nominate the nominee? (Maximum 2,000 characters)
- Please provide examples of international collaborative projects (including international development, humanitarian assistance, international solidarity/advocacy) that the nominee has contributed to and describe the nominee's role for each of them. (Maximum 1,500 characters)
- Please provide examples of local (Alberta/Canada) collaborative projects that the nominee has contributed to and describe the nominee's role for each of them. (Maximum 1,500 characters)
- How has the candidate ensured that those most impacted by an issue being addressed are included, heard, and their experience and perspectives centered in the work? (Maximum 1,000 characters)
- How is the nominee working towards gender equality and the Sustainable Development Goals? (See at https://sustainabledevelopment.un.org. Maximum 2,500 characters)

Nominators will also have the option to send up to 3 supplementary materials, such as letters of recommendation, articles, etc. to top30under30@acgc.ca, with the nominee's name in the email subject line, in addition to the nomination form.
